- All Regular & Private Tours:

- + Online & email Bookings with 100% payment to guarantee booking;
- + All cancellations until 24h prior to the Tour will be refunded 100% of booking payment;
- + All cancellations due to COVID19 or any public Health situation, local or abroad, until the Tour, will be refunded 100% of booking payment;

- All Private Yacht Charters (rentals) - Groups until 18 pax:

- + All reservations with 50% payment to guarantee booking;
- + The remaining 50% can be payed at check-in, before the Event; For Agencies & Partner Operators: until 5 days before the Event;
- + All cancellations until 24h prior to the Event will be refunded 100% of booking payment;
- + All cancellations due to COVID19 or any public Health situation, local or abroad, until the Event will be refunded 100% of booking payment;

- All Private Events - (Large Groups until 1000 pax):

- + All reservations with 50% payment to guarantee booking;
- + The remaining 50% can be payed until 10 days before the event;
- + All cancellations until 30 days prior to the Event will be refunded 100% of booking payment;
- + All cancellations due to COVID19 or any public Health situation, local or abroad, until 3 days before the Event will be refunded 100% of booking payment;
